AGENTS ALSO EARN A SMALL TRANSACTION FEE TO IMPROVE THEIR OWN LIVES.

IN FY21, 2,390 NEW AGENTS WERE ADDED TO THE GRAMEEN FOUNDATION USA (GRAMEEN) COMMUNITY AGENT NETWORK. EACH FINANCIAL SERVICES AGENT REACHES AN AVERAGE OF 266 NEIGHBORS IN HER COMMUNITY. AGENTS ARE A KEY COMPONENT OF GRAMEEN PROGRAMS IN MULTIPLE COUNTRIES. IN INDIA, FOR INSTANCE, 904 COMMUNITY AGENTS ARE SERVING 1,123 LOW-INCOME VILLAGES IN 5 DISTRICTS, INCLUDING 600,000 PEOPLE IN THE NAGPUR DISTRICT AND 40,000 PEOPLE IN THE NASHIK DISTRICT. IN GHANA, 9,000 FEMALE ENTREPRENEURS

WE FOCUS ON ENSURING THAT ORGANIZATIONS WORKING ON POVERTY AND HUNGER ARE EQUIPPED WITH THE BEST MINDS AND TECHNOLOGY TO HELP THEM SERVICE MARGINALIZED FAMILIES EFFICIENTLY AND EFFECTIVELY.
